## Executive Summary

In January 2025, the Town of Salem initiated Phase I of a Recreation Master Plan to inventory existing facilities, engage the public, and establish community-supported goals and objectives for the future of parks and recreational opportunities. This planning effort involved collaboration with Town departments and was led by the Recreation Advisory Committee. More than 250 residents participated in the planning effort, sharing their priorities for parks and recreation and their vision for the future in a community-wide survey as well as public workshops held during Phase I.

Phase I focuses on a high-level inventory completed by Salem Town Staff, the development of goals, objectives, and vision statement, preliminary community engagement, a preliminary level of service (LOS) analysis, and the development of constraints and opportunities for two, underdeveloped priority sites. This report begins to define a long-term vision for improving access, connectivity, and the overall quality of open space as well as parks and recreational facilities in Salem and lays the foundation for a complete Recreation Master Plan in the future. The Recreation Master Plan was divided into phases due to limited funding.

An additional phase would be required to fully complete the Recreation Master Plan. Phase II of the planning would include an in-depth description and analysis of current and future recreational needs, additional community engagement to confirm agreement with the Recreation Advisory Committee's vision and goals, and to determine preferences for parks, recreational facilities, and programs. Additionally, Phase II would identify policies, strategies, and the level of investment needed to sustain and improve parks and recreation services in alignment with the Town's vision statements, goals, and objectives. This phase would lay out short- and long-term strategies that the Town can use in making decisions about funding, managing, maintaining and improving the Town's parks and open spaces.

The Phase I Salem Recreation Master Plan contains eight sections:

- **Section 1:** *Introduction* of the Phase I planning process.
- **Section 2:** *Vision Statement* describes the Town's core values, vision, mission and goals for parks, recreation, and open space.
- **Section 3:** *Goals & Objectives* describe the Town's goals and corresponding objectives, influenced by the Vision Statement.
- **Section 4:** *Public Engagement & Outreach* presents the results of workshops and public survey.
- **Section 5:** *Inventory of Parks & Recreation Lands* provides an inventory of all parks, recreation, and open space lands owned by the Town of Salem.
- **Section 6:** *Priority Sites* discusses the two opportunity parcels selected by the Recreation Advisory Committee, their constraints, and their opportunities.
- **Section 7:** *Level of Service* outlines the preliminary LOS of Phase I.
- **Section 8:** *Next Steps* discusses the planning needs to complete the Plan.

## The Vision for Parks and Recreation

Through community feedback, and developed by the Recreation Advisory Committee, the following vision emerged: *Salem is committed to expanding and enhancing parks, trails, and open space while creating a connected, accessible, and well-maintained network of active recreation, passive open spaces, and conservation areas for all residents.*

# Section 1 Introduction

The 2025 Salem Recreation Master Plan is the first phase of a comprehensive planning document that guides future policies and actions by examining the Town's need for new or improved parks, recreation facilities, and open spaces. The Recreation Master Plan was divided into phases due to limited funding. A comprehensive plan such as this is important for many reasons. It identifies park and recreation assets; prioritizes needs; outlines goals, objectives, and actions; and enables the Town to pursue state and federal grants for capital improvements and land protection efforts. More specifically, this Phase I Plan:

- Outlines the community's vision and key goals for parks and recreation.
- Describes existing conditions and highlights current needs and opportunities.
- Summarizes community preferences gathered through surveys and workshops.
- Identifies two priority sites for further evaluation and potential redevelopment.

The Plan is structured into eight (8) sections, each contributing to a comprehensive understanding of Salem's current conditions and future opportunities.

## 1.1 Purpose & Scope

The overall purpose of parks and recreation in Salem is to provide Salem's residents with a diverse system of interconnected parks and quality recreational opportunities that protect natural resources, promote public health, and enhance the quality of life. The initial phase of Salem's Recreation Master Plan will focus on gaining knowledge, setting goals, conducting preliminary data gathering and analysis, and performing public outreach to inform later stages of the planning work. This Plan does not fulfill the scope for a complete Recreation Master Plan; rather, it establishes the foundation for additional analysis and development of strategies to maintain and improve parks and recreation facilities in the future.

## 1.2 Planning Process Overview & Timeline

The development of the Salem Parks and Recreation Master Plan followed a collaborative and community-focused planning process, launched in January 2025. The process began with a kickoff meeting with Town staff and the Town's Recreation Advisory Committee (RAC). The in-person RAC kickoff meeting was held on January 15, 2025, and provided a foundation for development of the Phase I Plan's goals, objectives, and overall needs.

The kickoff meeting was followed by one virtual and one in-person workshop with the RAC, held on January 30 and February 13, 2025, respectively. These sessions focused on drafting a shared vision statement, outlining key goals and objectives, and developing the public outreach strategy. These foundational elements served as a guiding framework for the remainder of the Phase I effort.

To support a data-informed approach, the planning team developed an interactive ArcGIS web map using the Town's GIS data layer of existing parks to inventory park and open space assets across Salem. This tool also integrated state and regional resource layers such as conservation lands, trails, and water bodies, providing context for the locations of parks and open space. In parallel, on-the-ground assessments were conducted using Survey123, a GIS-based mobile data collection application. Using this tool, Town staff

evaluated conditions at all Town-owned facilities, documenting safety, accessibility, amenities, and general upkeep. These observations were geo-tagged and compiled into an interactive database to support future facility planning and prioritization. The RAC met on March 3, 2025, to launch the community survey and review findings for the Survey123 inventory collection program.

A citizen survey was launched on March 6, 2025, and remained open through May 15, 2025, to gather broad community input. The 19-question survey explored how residents use parks, what amenities they value, and what improvements they would like to see. The survey was promoted on the Town's website, social media platforms, and at Town Hall. A total of 251 surveys were completed, offering a meaningful snapshot of community preferences.

Following the community engagement phase, the RAC reconvened for a virtual meeting on June 5, 2025, to review survey results, discuss field assessment findings, and provide input on emerging themes and site-specific considerations.

To complement the survey, a public Visioning Workshop was hosted virtually on June 12, 2025. RAC members participated in discussions focused on recreation priorities, emerging needs, and ideas for future investments. Tighe & Bond presented the final feedback received from the community survey as well as reviewed two draft priority site diagrams and presented the draft LOS analysis. This workshop provided a valuable opportunity for engagement and idea sharing.

The planning process concluded with a formal presentation of the draft Plan at Salem Town Hall during a public meeting on August 14, 2025, which was also attended by members of the RAC. This final step ensured that the Plan was vetted by key Town boards and stakeholders, helping to build consensus and momentum for implementation.

## Section 2 Vision Statement

The values and aspirations of Salem residents serve as the foundation for the Phase I 2025 Recreation Master Plan. Through a series of public engagement efforts, residents shared their values, needs, and expectations for the future of parks and recreation in Town. This input, combined with guidance from the RAC and Town staff, informed the creation of a community vision statement to guide this Plan.

Key themes from the public and RAC included:

- Expanding parks and green spaces while balancing active and passive recreation.
- Connectivity was a major focus, with a desire for linked park networks, expanded bike trails, improved pedestrian access, as well as safety and maintenance at existing facilities.
- Preserving historical and cultural assets, such as veterans' memorials and the Depot area.
- Increasing programming across all facilities.
- Increasing conservation efforts through pollinator gardens and wildlife education.

The vision reflects the desire for a connected, inclusive, and resilient park and recreation system that enhances quality of life for all residents, while protecting the Town's natural and cultural resources.

The following vision emerged:

***Salem is committed to expanding and enhancing parks, trails, and open space while creating a connected, accessible, and well-maintained network of active recreation, passive open spaces, and conservation areas for all residents.***

This statement captures a shared outlook for Salem's future, one in which public spaces support healthy lifestyles, environmental stewardship, community connection, and a strong sense of place.

## Section 3 Goals & Objectives

The Town compiled a list of goals and objectives to coordinate future actions to improve their parks and recreation facilities. The list below was developed and reviewed by the RAC and through consultation with Town staff, with consideration of community input from the survey results as well as discussions from the public workshops.

Salem's 2025 parks and recreation goals and objectives are as follows:

### **Goal 1: Enhance Accessibility and Equity in Recreation Spaces**

- Objective 1.1: Ensure safe pedestrian and bike access to parks, trails, and green space by connecting sidewalks and pathways in key neighborhoods.
- Objective 1.2: Identify opportunities to create pocket parks and green spaces in neighborhoods lacking proximity to the existing network.
- Objective 1.3: Increase access to public waterbodies for passive recreation, swimming, fishing, etc.
- Objective 1.4: Maintain and improve existing park infrastructure such as playgrounds and courts to ensure a safe and accessible system.
- Objective 1.5: Enhance inclusive, recreational programming across all demographics from senior citizens to summer camp children.
- Objective 1.6: Enhance lighting in parks for evening use.

### **Goal 2: Improve Connectivity Across Network of Parks**

- Objective 2.1: Complete and maintain the Rail Trail, including historic and wildlife signage along the route.
- Objective 2.2: Explore funding opportunities for linking parks, open spaces, and waterbodies through bike trails and greenways.
- Objective 2.3: Expand upon a comprehensive trail network in the Town Forest to connect conservation and recreation areas.

### **Goal 3: Expand Recreation Opportunities to Meet Community Needs**

- Objective 3.1: Increase the number of playgrounds, ballfields, and courts to meet the needs of Salem residents.
- Objective 3.2: Create and implement new recreational facilities and amenities such as skate parks, dog parks, splash pads, public restrooms, and expanded parking.
- Objective 3.3: Blend passive and active recreation by incorporating pollinator gardens, walking trails, and organized hikes in parks and conservation areas.

### **Goal 4: Foster Environmental Stewardship and Public Education**

- Objective 4.1: Partner with garden clubs and other organizations to establish pollinator gardens and enhance conservation efforts.
- Objective 4.2: Install educational signage about local wildlife and natural resources in parks and along trails.

- Objective 4.3: Develop programs like organized hikes, wildlife education, and nature-based workshops in collaboration with local groups and organizations.

**Goal 5: Celebrate Cultural & Historic Heritage**

- Objective 5.1: Increase cultural programming, including events at gathering spaces and art installations at the Depot area.
- Objective 5.2: Preserve and highlight historical features of parks with signage and public education initiatives.
- Objective 5.3: Partner with local groups to integrate memorials for veterans and other historic events into park planning and programs.

The goals and objectives outlined in this Plan are designed to ensure that the Town's natural and recreational resources are managed effectively, equitably, and sustainably. By focusing on preservation, accessibility, community engagement, and resiliency, Salem can create a vibrant network of park and recreation facilities that enhances the quality of life for current and future generations. The successful implementation of these goals will not only protect the Town's natural beauty but also foster a sense of pride, community well-being, and environmental stewardship among all residents.

The next step in the Recreation Master Plan process is to translate these priorities into a clear and actionable 7-10-Year Action Plan. Phase II of this plan would outline specific projects, policies, and initiatives that respond directly to the identified goals and objectives, while addressing existing gaps in service, protecting critical resources, and enhancing recreational opportunities for all residents. Each action item would include details on responsible parties, potential funding sources, and a proposed timeline for implementation. This next phase ensures that the community's shared vision is carried forward through targeted investments and coordinated efforts across municipal departments, boards, and local partners.

## Section 4 Public Engagement & Outreach

Community input played a central role in shaping Phase I of the Salem Recreation Master Plan. A multi-faceted outreach approach was used to ensure broad and diverse public participation. This included a community-wide survey, and four public workshops to share ideas and identify priorities in real time. Together, these engagement efforts provided critical insights into how Salem residents use existing facilities, what they value most in their recreational spaces, and where they see opportunities for improvement.

The feedback gathered directly informed the vision, goals and objectives, and recommendations of this Plan.

### 4.1 Public Workshops

A total of four (4) Public Presentations/Workshops were hosted by the Town of Salem either virtually or in person at Town Hall. All workshops were facilitated by Tighe & Bond. Major themes and take ways from each workshop are included below:

- Workshop #1 - January 30, 2025 – Virtual workshop to discuss Vision, Goals, and Objectives.
- Workshop #2 – February 13, 2025 – In-Person workshop to confirm draft Vision, Goals, and Objectives and establish method for inventory collection and public engagement.
- Workshop #3 – June 12, 2025 – Virtual workshop to present final Vision, Goals and Objectives, as well as the results of the public survey and draft Level of Service (LOS) Analysis.
- Workshop #4 - August 14, 2025 – In-person workshop to present the Draft Plan and final opportunity site diagrams and LOS analysis.

## 4.2 Community Survey

A citizen-based survey consisting of nineteen (19) questions was developed via SurveyMonkey to better understand residents' values, preferences, and priorities regarding the Town's parks, open spaces, and recreational amenities. The survey included a mix of multiple-choice, rating scale, and open-ended questions and was designed to capture both general satisfaction levels and specific ideas for improvement.

The questionnaire was made available on the Town's website, social media platforms, and at the Town Hall. Postcards and flyers with a quick response code (QR Code) to access the survey were distributed at community locations. The survey was available from March 6, 2025 to May 15, 2025. The full survey with results can be found in Appendix B.

Respondents were asked about how frequently they visit local parks and trails, which locations they use most often, and what types of recreational activities they participate in. Many questions focused on identifying which facilities and programs are most important to the community, such as walking trails, playgrounds, sports fields, natural areas, and cultural or community events. Residents were also asked to rank potential priorities for future investment, such as upgrading existing facilities, acquiring new parkland, or expanding programming for youth or seniors.

The survey also asked about barriers to park access, including lack of transportation, awareness, or concerns about safety or accessibility. Demographic questions helped capture a diverse range of perspectives across different age groups and neighborhoods.

Open-ended questions gave residents an opportunity to share specific suggestions and highlight community needs that may not be captured in structured responses. Many participants expressed a desire for better maintenance, more walking and biking connections between parks, and additional opportunities for passive recreation and nature experiences. The respondents highlighted specific needs, such as relocating the skate park, adding a dog park, increasing water access, and increasing public amenities such as restrooms.

Several key themes and community priorities emerged that will inform future planning and development of parks and recreation facilities. Respondents to the survey highly value parks and recreation, with over 72% rating them as "very important." Popular facilities include the Rail Trail, Town Forest, and Field of Dreams, which were among the most visited and highly ranked in terms of usage. However, access and awareness of a park's location and amenities vary significantly across facilities, with some parks like Linwood Ave Park and Hedgehog Park being underused, often due to concerns about maintenance, safety, or lack of amenities.

When asked about satisfaction across different age groups, the results indicate room for improvement. While a majority of residents feel neutral to positive about recreation options for children, satisfaction drops notably for teens and adults. Concerns included a

lack of teen-friendly spaces, insufficient passive recreation areas, and limited year-round programming. Many respondents noted barriers such as poor facility conditions, limited parking, safety concerns, and lack of awareness about existing parks.

Conservation and expansion of open space are clear priorities. A strong majority of respondents (77%) support preserving additional land for scenic views, wildlife, and trails. Respondents also expressed strong interest in enhancing existing parks, expanding hiking and biking trails, improving ADA accessibility, and adding amenities such as splash pads, restrooms, dog parks, and educational programming.

In terms of funding, 88% of respondents are receptive to allocating Town resources toward these improvements, with top priorities including the maintenance of current facilities, land preservation, and developing diverse recreational options for all age groups.

A total of 251 online surveys were completed. Respondents reflected a range of ages, neighborhoods, and recreational interests. Overall, the survey highlights a well-engaged community eager for thoughtful investment in open space and recreation that supports conservation, park maintenance, and accessibility. These findings provide a strong foundation for shaping a community-driven plan.

# Section 5 Inventory of Parks & Recreation Lands

## 5.1 Existing Parks & Recreation Data

This section provides a comprehensive summary of Salem's existing parks and recreation lands. These include Town-owned parks and conservation areas only and does not include privately-owned open spaces and recreational areas managed by other organizations, such as the school. This data forms the foundation for identifying gaps in service and areas for improvement.

The Town of Salem maintains approximately 650 acres of public parks, open space, and recreational land across 16 sites. These parks support a wide range of recreational, environmental, and community uses and are essential to the quality of life for Salem residents.

## 5.2 Inventory Methodology

Town staff and the RAC utilized Survey123, a mobile GIS-based data collection tool, to conduct on-site evaluations of Salem's parks and recreation facilities. This method allowed staff to systematically assess the condition, safety, accessibility, and amenities of each park using a standardized digital form. Observations were recorded in real time and geo-tagged, providing an interactive and spatially accurate inventory of current park conditions.

Data collected through Survey123 included metrics such as the presence and quality of amenities (e.g., benches, restrooms, trails), and notes on accessibility and maintenance concerns. A total of 16 facilities were evaluated using this tool. This on-the-ground input provided an objective complement to the community survey and workshop feedback, yielding valuable information to identify facility gaps, prioritize capital improvements, and align park features with community needs.

The Survey123 inventory table is provided in Appendix C.

## 5.3 Park Classification and Description

To guide the analysis of future park needs, Salem's parks and recreation facilities have been classified into three distinct types based on their scale, purpose, and amenities: Mini Parks, Neighborhood Parks, and Community Parks. This typology is widely used in parks planning and is tailored here to reflect Salem's specific facility inventory and community needs. These adapted standards were developed by the National Parks and Recreation Association.

### 5.3.1 Mini Parks

Mini Parks are small public spaces, typically under two acres, that serve nearby residents and are located within walking distance of neighborhoods. These parks offer limited recreational opportunities and generally include features such as open lawns, benches, small playgrounds, or memorials.

- Little Saugus Field (1 acre)
- Veterans Memorial (5 acres; 2 usable)
- William Valentine Park (0.5 acres)

### 5.3.2 Neighborhood Parks

Neighborhood Parks are moderately sized and designed to serve surrounding neighborhoods with features like playgrounds, multi-use fields, and passive open space. These parks typically support daily, unstructured use and small gatherings.

- Millville Recreation Area (38 acres)
- Walmart Field (2 acres)
- Lawrence Road Recreation Area (5 acres; 1 usable).

### 5.3.3 Community Parks

Community Parks are larger, multi-use spaces that support both active and passive recreation for the entire community. These parks often include athletic fields, walking trails, forestland, and event spaces. Some also provide access to natural resources such as wetlands or wildlife corridors.

- Field of Dreams (7 acres; 5 usable)
- DiBenedetto Field (78 acres; 6 usable)
- Palmer School Field (8 acres)
- Town Forest (350 acres)
- Hedgehog Park (28 acres; 20 usable)
- Linwood Avenue Park (8 acres; 2 usable)
- Michele Memorial Park (48 acres; 34 usable)
- Morse Field (14 acres; 7 usable)
- Rail Trail (37 acres)
- Senior Center Grounds (16 acres; 6 usable)

### 5.3.4 Park Inventory

Inventory data was compiled using a combination of GIS analysis, Town Assessor records, and publicly available datasets from state agencies and regional planning commissions. Input from Town staff through the Survey123 application helped verify and supplement the dataset.

Of the 645 acres included in Salem's recreation inventory, a substantial portion, particularly in the Town Forest and Rail Trail, offers passive recreational opportunities such as hiking, walking, and nature appreciation. However, usable acreage (520 acres) for active recreation is more limited, especially in parks with environmental constraints such as wetlands, steep slopes, or conservation easements. Understanding the difference between total and usable acreage is critical for planning future recreational investments and prioritizing improvements.

# Section 6 Priority Sites

## 6.1 Site Selection

Three priority sites, Millville Recreation Area, Lawrence Road Recreation Area, and Little Saugus Field, were identified for a more focused analysis. These sites were selected by Town Staff, the RAC, and supported by feedback from the community survey, based on their location, existing conditions, potential for community benefit, and alignment with Town goals.

These sites are shown in the opportunity figures in Appendix D.

## 6.2 Site #1 – Millville Recreation Area

Site #1 includes seven parcels (Parcel IDs: 57-6855-0, 57-2578-0, 57-2579-0, 57-2595-0, 66-2678-0, 57-2598-0, and 57-2597-0) and is located in the Residential (R) zoning district near Millville Lake. The site features a mix of water resources, deciduous forest, and water courses.

The area was repeatedly cited by residents during the public engagement process as a desirable location for improved recreational amenities, particularly access to water and swimming. The RAC and Town staff also identified this area as a high priority, and the site has previously been considered by the Town as a potential opportunity for recreation development. Permitting needs have not yet been evaluated.

The sections below outline the existing environment, constraints, and opportunities at the Millville site.

### 6.2.1 Existing Environment

- Approximately 38 acres across two main clusters of parcels, separated by Widow Harris Brook.
- Extends from Glen Denin Drive on the east to Millville Circle and Millville Lake on the west.
- Includes forested land, a small existing beach area, and wetlands.
- A small parking lot exists off Millville Circle.
- The area is mostly undeveloped woodland with sloping topography (approx. 180' to 140' elevation).

### 6.2.2 Constraints

- The site is divided by conservation easements, wetlands, and a small sliver of one non-Town-owned parcel.
- The western portion is not level and would require significant regrading, tree removal, and retaining walls to accommodate active recreation facilities.
- Widow Harris Brook, the 100-year flood zone, and a conservation easement present barriers to connecting the eastern and western areas. A boardwalk crossing would require access over a non-Town-owned parcel.

- Proximity to adjacent residences may cause potential conflicts such as traffic, noise, and lighting.
- **Western Parcel:** Potential to accommodate one baseball field, one softball field, and one soccer field, with significant challenges:
  - Extensive site work needed (regrading, retaining walls, stormwater management).
  - Likely removal of woodland buffer between residences and fields.
  - Parking and access road construction required.
- **Eastern Parcel:** Better suited for limited active recreation:
  - Two soccer fields could fit with optimal orientation.
  - A softball field fits but would encroach on a designated wildlife corridor and limit space for parking.
  - Parking is possible with access from Glen Denin Drive.
  - Fields would still require grading (10–15' elevation change) and tree clearing.
  - Facilities would be near homes, and some may encroach on conservation easements.
- **Water Access Area:**
  - Road realignment may be needed.
  - No accessible pathway currently connects the street to the beach.
  - Parking in the wide intersection is informal and unsafe.
  - Limited visibility from the road to the water.

### 6.2.3 Opportunities

- **Improved Water Access:**
  - Enhancing and formalizing the beach area is a high-feasibility, low-impact option.
  - Proposed improvements include:
    - Boardwalk and dock installation.
    - ADA-compliant (5% grade) accessible pathway and stairs from street to beach.
    - Tree limbing or removal near the crosswalk to improve visibility.
    - Slope revegetation with native plants.
    - Crosswalk, sidewalk, and right-angle intersection to improve pedestrian safety and access.
    - 10-space parking area with a planted buffer strip.
- **Woodland Trails:**
  - More than a mile of trails could be developed across both parcel groups.
  - A pedestrian bridge over Widow Harris Brook could link the east and west portions, pending easement negotiations or acquisition.

- Trails would enhance passive recreation and offer scenic connections to Millville Lake.

The Millville Recreation Area offers a rare opportunity in Salem to improve water access, enhance trail connectivity, and expand passive recreation in a largely undeveloped, wooded area. While significant constraints limit the feasibility of large-scale active recreation facilities, such as steep slopes, wetlands, floodplains, and adjacent residential uses, there is strong community interest in enhancing this site. Improvements that focus on accessible water access, woodland trails, and light-touch recreational amenities would provide high community value while maintaining the site's natural character.

## 6.3 Site #2 – 73 Lawrence Road

The Lawrence Road Recreation Area is a single parcel approximately 5 acres in size, located at the corner of Lawrence Road and Veterans Memorial Parkway. The site is positioned adjacent to a busy intersection and directly across Lawrence Road from the Salem Senior Center, which could provide additional shared parking opportunities. The parcel features open lawn, marshland, and wetland resources and is adjacent to a residential retirement community.

While the site is currently underutilized, it presents strong potential for passive recreation, particularly nature-based amenities that could serve older adults and nearby residents. It was identified as a high-potential site during public engagement for its accessibility, visibility, and open character.

The sections below outline the existing environment, constraints, and opportunities at the Lawrence Road site.

### 6.3.1 Existing Environment

- Approximately 8-acre parcel containing open mown lawn and natural areas with wetland resources.
- The western portion of the site is entirely constrained by wetlands, a mapped wildlife corridor, the 500-year floodplain, and the 100-year floodplain.
- Informal pull-off area used for limited parking.
- Maintained but undeveloped green space.
- Directly across the street from the Salem Senior Center, offering potential for shared access or overflow parking.

### 6.3.2 Constraints

- The parcel is bordered by a high-traffic intersection with wide-radius corners that promote speeding and reduce pedestrian safety.
- Any improvements must include traffic calming and intersection design changes to safely support new park uses.
- Invasive plants are present within the lawn area and along the wetland edge.
- The site lacks accessible, designated parking.

- The western half of the site is heavily constrained due to environmental conditions including wetlands, mapped wildlife habitat, and overlapping 100- and 500-year floodplains, which limits the footprint for new facilities.

### 6.3.3 Opportunities

- **Traffic and Safety Improvements:**
  - Install high-visibility crosswalks using contrasting surface materials to draw driver attention.
  - Redesign the intersection to reduce turning radii and vehicle speeds.
  - Add a fence or natural barrier between the lawn and roadway to improve safety and define park boundaries.
- **Park Enhancements:**
  - Remove invasive vegetation and establish a native meadow.
  - Construct a nature-themed playground that aligns with the passive character of the site.
  - Build a boardwalk extending into the wetlands to offer wildlife viewing and nature interpretation without disrupting sensitive resources.
  - Include a gazebo, bocce ball courts, or space for lawn games to support intergenerational use.
  - Create a circular walking path within the open lawn for low-impact exercise.
- **Accessibility and Parking:**
  - Construct a small, formal parking area with ADA spaces.
  - Explore the use of the Senior Center parking lot for shared access or overflow parking, especially given its proximity and alignment with the intended user base.
  - Consider a designated pull-off area to accommodate drop-off/pick-up for older adults or visitors with limited mobility.

With targeted improvements and careful design, the Lawrence Road Recreation Area can become a signature neighborhood park that enhances local open space offerings, improves public safety, and provides inclusive recreational opportunities for all ages and abilities, especially older adults living nearby.

## 6.4 Site #3 – Little Saugus Field

Little Saugus Field is a compact pocket park located in the heart of a residential neighborhood. The site combines a wide open lawn with a small wooded knoll at the northern end, providing open recreation space. With its central location and strong accessibility, the site could serve as a gathering place for families and children and has the potential to support both active and passive recreation in a highly walkable setting.

The sections below outline the existing environment, constraints, and opportunities at Little Saugus Field.

#### 6.4.1 Existing Environment

- Small neighborhood park with open lawn and a wooded knoll at the northern end.
- Located in the center of a residential neighborhood, easily accessible by walking and biking.
- Maintained green space with opportunities for both informal recreation and programmed use.

#### 6.4.2 Constraints

- Limited acreage restricts the size and number of facilities that can be accommodated.
- Active recreation (soccer, tee-ball) may compete with space for other amenities such as playgrounds or picnic areas.
- Parking is limited, with most access anticipated to be via walking or biking from the surrounding neighborhood.

#### 6.4.3 Opportunities

- **Recreation Enhancements:**
  - Very limited space for a U9/U10 soccer field or a 50' baseline tee-ball field to serve youth sports.
  - Space to install a small playground to support neighborhood families.
  - Maintain part of the lawn as flexible open space or convert a portion into a pollinator meadow.
- **Passive Use and Community Amenities:**
  - Add a pergola, gazebo, or picnic pavilion to support social gatherings and family use.
  - Walking path around the site measures approximately 1/5th of a mile, supporting walking, jogging, and low impact exercise.

With its walkable location, open character, and open lawn areas, Little Saugus Field has strong potential to serve as a family-oriented neighborhood park. Modest enhancements would broaden recreational opportunities, create a balance between active and passive uses, and strengthen its role as a valued community gathering space.

### 6.5 Priority Sites Constraints and Opportunities Summary

The Priority Sites represent distinct opportunities to enhance Salem's open space and recreation system. While each site presents its own set of environmental, logistical, and design constraints, both offer meaningful potential for community-driven improvements.

The table below illustrates a summary of constraints and opportunities at the sites.

## 6.6 Alignment of Priority Sites with Goals & Objectives

The Priority Sites represent distinct opportunities to enhance Salem's open space and recreation system. While each site presents its own set of environmental, logistical, and design constraints, all offer meaningful potential for community-driven improvements.

The Priority Sites closely align with Salem's goals for accessibility, connectivity, environmental education, and community-focused recreation. Each site presents a distinct opportunity: Millville for trail and water access improvements in a natural setting, Lawrence Road for creating a neighborhood park with inclusive, low-impact amenities, and Little Saugus Field for a mini park in walking distance to residential areas. Together, these priority sites reflect a balanced approach to meeting community needs.

This section expands on the alignment of the two sites with the plan's goals and objectives.

### 6.6.1 Millville Recreation Area

#### Goal 1: Enhance Accessibility and Equity in Recreation Spaces

- **Objective 1.1:** Enhances pedestrian access by proposing sidewalk connections and crosswalk improvements, especially near the water access point.
- **Objective 1.3:** Directly supports increased access to a public waterbody for passive recreation, swimming, and fishing.
- **Objective 1.5:** Opportunities for accessible nature-based programming (e.g., trails, beach access) serve a wide range of ages and abilities.

**Goal 2: Improve Connectivity Across Network of Parks**

- **Objective 2.2:** Bridge and trail network could connect Millville with other neighborhoods or future greenways.
- **Objective 2.3:** Expands Salem's overall trail network with more than a mile of potential woodland walking trails.

**Goal 3: Expand Recreation Opportunities to Meet Community Needs**

- **Objective 3.1:** While full-scale field development is limited, conceptual field layouts show the site's long-term potential.
- **Objective 3.3:** Incorporates walking trails, nature observation, and passive recreation.

**Goal 4: Foster Environmental Stewardship and Public Education**

- **Objective 4.2:** Potential for interpretive signage about the wetland, wildlife corridor, and Widow Harris Brook.
- **Objective 4.3:** Woodland trails and boardwalk areas provide a strong foundation for nature-based education and organized programming.

**6.6.2 Lawrence Road Recreation Area****Goal 1: Enhance Accessibility and Equity in Recreation Spaces**

- **Objective 1.1:** Improves pedestrian safety and access through crosswalks, traffic calming, and proximity to the Senior Center.
- **Objective 1.2:** Functions as a small-scale green space (pocket park) in a highly accessible neighborhood area.
- **Objective 1.4:** Introduces new infrastructure (e.g., gazebo, bocce, walking loop) designed for accessibility and inclusivity.
- **Objective 1.5:** Proposed amenities are age-friendly and suited to both seniors and families, supporting inclusive recreation.

**Goal 3: Expand Recreation Opportunities to Meet Community Needs**

- **Objective 3.2:** Adds new amenities such as seating areas, walking loops, and small game courts.
- **Objective 3.3:** Incorporates meadow restoration, wetland boardwalks, and passive recreation opportunities.

**Goal 4: Foster Environmental Stewardship and Public Education**

- **Objective 4.1:** Meadow creation supports pollinator habitat and provides a partnership opportunity with local groups.
- **Objective 4.2:** Boardwalk area provides a platform for educational signage and environmental interpretation.

### 6.6.3 Little Saugus Field

#### Goal 1: Enhance Accessibility and Equity in Recreation Spaces

- **Objective 1.2:** Functions as a small-scale, highly accessible pocket park in the heart of a residential neighborhood.
- **Objective 1.4:** Introduces new infrastructure such as a playground, walking path, and pergola/pavilion designed for accessibility and inclusivity.
- **Objective 1.5:** Proposed amenities support families and children, offering opportunities for intergenerational recreation and small-scale community programming.

#### Goal 2: Improve Connectivity Across Network of Parks

- **Objective 2.2:** Enhances neighborhood connections by linking walking paths to surrounding sidewalks and nearby green spaces.

#### Goal 3: Expand Recreation Opportunities to Meet Community Needs

- **Objective 3.1:** Provides space for youth sports, including a U9/U10 soccer field or tee-ball diamond.
- **Objective 3.3:** Balances active and passive recreation through walking paths, flexible open lawn, and a playground.

#### Goal 4: Foster Environmental Stewardship and Public Education

- **Objective 4.1:** Potential to establish a meadow or pollinator garden in partnership with local groups.
- **Objective 4.2:** Opportunities for educational signage about neighborhood ecology or pollinator species.

#### Goal 5: Celebrate Cultural & Historic Heritage

- **Objective 5.1:** Site could host small-scale community or cultural programming, such as art installations or seasonal events.

# Section 7 Level of Service

To inform the LOS analysis, data from the National Recreation and Park Association (NRPA) 2025 Agency Performance Review was incorporated. This national dataset aggregates information from nearly 1,000 park and recreation agencies across the country and offers median service levels based on community size.

Importantly, NRPA emphasizes that its performance metrics are not prescriptive standards but guidelines to help communities benchmark themselves against similar jurisdictions. Each community's park system should reflect its unique character, geography, and recreational priorities. In Salem, this means considering not only the number of parks and amenities, but also the quality, accessibility, and geographic distribution of these resources across neighborhoods.

## 7.1 Level of Service Analysis

The LOS analysis is a critical component of assessing how well Salem's existing parks and open space system is serving the needs of its residents. This analysis considers both the quantity and distribution of parkland and recreational amenities in relation to the town's population, as well as how Salem compares to national benchmarks. The LOS analysis helps identify gaps in service and areas where future investment may be needed to meet demand and access to open space.

Salem currently provides approximately 645 acres of parks and open space across 16 publicly accessible sites. With a population of 31,549, this equates to roughly:

- 2,103 residents per park
- 20.6 acres of parkland per 1,000 residents

These figures compare favorably to the 2025 National Recreation and Park Association (NRPA) Agency Performance Review<sup>1</sup>, which reports a typical benchmark of:

- 2,386 residents per park
- 10.6 acres of parkland per 1,000 residents

Even when excluding the 350-acre Town Forest from Salem's total, bringing the usable parkland figure to about 295 acres, Salem still meets the national benchmark with 9.4 acres per 1,000 residents, suggesting the community is relatively well-served in terms of total acreage.

While the total acreage figure suggests that Salem benefits from a relatively high amount of open space, the number of park sites and types of amenities available may not fully reflect the recreational needs of Salem's population. For example, the Town currently has two basketball courts and four tennis courts, resulting in approximately one basketball court for every 15,775 residents and one tennis court per 7,887 residents. These ratios

suggest that some recreational facilities may be underprovided relative to demand, as further expanded upon below.

### 7.1.1 Distribution and Access

As part of this Phase I planning effort, a Level of Service mapping analysis was completed to assess spatial distribution and community access to parks. This GIS-based analysis used the following park type-specific buffer distances that reflect the unique development and land use patterns in Salem:

- **Mini Parks:** Access radius of 1 mile
- **Neighborhood Parks:** Access radius of 1–2 miles
- **Community Parks:** Access radius of 2–3 miles

These distances are greater than the commonly used walkable standard of ½ mile, but are appropriate for a town with an auto-oriented layout like Salem. Buffers were generated around both the total parcel area and the "usable" parkland footprint to identify true service coverage. This approach helped determine where gaps in access exist, especially in areas with higher residential densities and limited walkability.

Overall, mini and neighborhood parks can be found near the center of town, while community parks are more widely distributed. The northern and southwest portions of town are noticeably lacking mini and neighborhood parks.

Distribution and access for each park was evaluated by reviewing the entire parcel as well as usable area only. LOS figures can be found in Appendix E.

### 7.1.2 Facility-Specific LOS

In addition to parkland coverage, the quantity of active recreational facilities in Salem was evaluated against NRPA benchmarks for typical communities with similar populations. Applicable facility types compared with NRPA benchmarks can be found in Table 7-1 below.

While Salem's trail mileage slightly exceeds the national average, the Town currently falls short of typical LOS for active recreational facilities like courts, fields, and playgrounds. These deficiencies are important to consider, particularly in growing neighborhoods and among age groups with specific recreational needs (e.g., youth sports, seniors, pet owners).

### 7.1.3 Summary

The LOS analysis demonstrates that while Salem has a generous overall supply of parkland, especially when large natural areas are included, the Town's number of park sites and active recreational facilities lags behind national averages. Addressing these gaps, particularly in neighborhoods underserved by parks or lacking playgrounds, courts, or sports fields, will be essential for improving access to park and recreation facilities townwide to meet future community needs. The results of the LOS analysis align with the feedback received from the Community Survey.

This analysis will help guide future land acquisition, park development, and amenity investment decisions, forming a foundation for Salem's evolving parks and recreation system.

## Section 8 Next Steps

This Recreation Master Plan represents Phase I of Salem's long-term vision to enhance open space, improve recreational opportunities, and promote environmental stewardship throughout the community. The work completed to date, including the development of goals and objectives, public engagement, and priority site identification, lays the foundation for a more detailed and actionable planning process in the next phase.

### 8.1 Future Phases of the Recreation Master Plan

The next phase of the Recreation Master Plan process could involve the following key components:

- **Demographics and Needs Analysis** - A comprehensive analysis of population trends, age cohorts, and regional recreational benchmarks will be conducted to better understand current and future needs.
- **Strategy Development** - Building on the goals and objectives established in Phase I, the Town will develop targeted strategies to guide decision-making and investment over the next seven to ten years.
- **Action Plan** - A detailed Action Plan will identify:
  - Recommended actions aligned with goals and objectives
  - Responsible parties (e.g., municipal departments, boards, community partners)
  - Priority level (High, Medium, or Low) for each action
  - Timeframes for implementation (Short-, Mid-, and Long-term)
  - Potential funding sources, including local, state, federal, and grant opportunities
- **Draft and Final Recreation Master Plan** - A full Recreation Master Plan will be prepared. This report will include all typical elements of a full Recreation Master Plan, such as the community vision, inventory of lands, needs analysis, action plan, and public process documentation.
- **Monitoring, Updating, and Tracking Progress** - Establishing a process for tracking implementation progress will be critical to the long-term success of the Recreation Master Plan. The Town will explore tools and methods for:
  - Monitoring completed actions
  - Updating the plan on a rolling basis
  - Reporting progress to Town leadership and the public

### **Introduction**

This memorandum outlines a draft vision statement, goals, and objectives for the Salem, New Hampshire Open Space and Recreation Plan. The draft vision statement, goals and objectives were developed based on meeting discussions, workshop brainstorm sessions, and community priorities identified through feedback on the Salem Master Plan.

The vision statement, goals, and objectives are intended to guide the planning process and ensure alignment with the community's open space and recreation needs.

Refinement of the vision statement, goals and objectives was completed as part of Workshop #2 on Thursday, February 13<sup>th</sup>. Further refinement of the vision statement was completed on February 24, 2025 as a result of feedback from the Recreation Advisory Committee.

### **Draft Vision Statement**

*Salem is committed to expanding and enhancing parks, trails, and open space while creating a connected, accessible, and well-maintained network of active recreation, passive open spaces, and conservation areas for all residents.*

### **Draft Goals & Objectives**

#### **Goal 1: Enhance Accessibility and Equity in Recreation Spaces**

- Objective 1.1: Ensure safe pedestrian and bike access to parks, trails, and green space by connecting sidewalks and pathways in key neighborhoods.
- Objective 1.2: Identify opportunities to create pocket parks and green spaces in neighborhoods lacking proximity to the existing network.
- Objective 1.3: Increase access to public waterbodies for passive recreation, swimming, fishing, etc.
- Objective 1.4: Maintain and improve existing park infrastructure such as playgrounds and courts to ensure a safe and accessible system.
- Objective 1.5: Enhance inclusive, recreational programming across all demographics from senior citizens to summer camp children.
- Objective 1.6: Enhance lighting in parks for evening use.

#### **Goal 2: Improve Connectivity Across Network of Parks**

- Objective 2.1: Complete and maintain the Rail Trail, including historic and wildlife signage along the route.

- Objective 2.2: Explore funding opportunities for linking parks, open spaces, and waterbodies through bike trails and greenways.
- Objective 2.3: Expand upon a comprehensive trail network in the Town Forest to connect conservation and recreation areas.

**Goal 3: Expand Recreation Opportunities to Meet Community Needs**

- Objective 3.1: Increasing playgrounds, ballfields, and courts to meet the needs of Salem residents.
- Objective 3.2: Create and implement new recreational facilities and amenities such as skate parks, dog parks, splash pads, public restrooms, and expanded parking.
- Objective 3.3: Blend passive and active recreation by incorporating pollinator gardens, walking trails, and organized hikes in parks and conservation areas.





## Q1: HOW IMPORTANT ARE PARKS AND REC TO YOU?









**Q8: WHAT NEIGHBORHOOD DO YOU LIVE IN?**




### Q14: DO YOU LIVE/WORK/ OR OWN A BUSINESS IN TOWN?

## Q1 How important are parks and recreation to you?




## Q2 How often do you visit/use each park and/or recreation area?













## MILLVILLE RECREATIONAL PARCELS

### EXISTING



- Parking Lot

### CONSTRAINTS

- Wooded area is divided by conservation easement, wetlands and a non-town owned parcel
- The western wooded area is not level, needing extensive regrading and tree removal for active recreational facilities
- The eastern parcel is also not ideal for active recreation facilities
- Recreational facilities would be too close to residential homes

### OPTIONS

- Improved / accessible water access area
- Woodland walking trails (a little more than a mile as shown)
- Boardwalk over Widow Harris Brook - path would crossover parcel not owned by the town posing challenges to linking the west and east sides
- Entrance on Glen Denin Dr



# PARKS & RECREATION OPPORTUNITY PARCELS

## MILLVILLE RECREATIONAL PARCELS - WESTERN PARCEL FITTING STUDY

### EXISTING CONSTRAINTS

- Woodland sloping SE from 180 to 140
- Significant regrading, tree removal, retaining walls required for construction of fields
- Site will need to contain stormwater runoff which will further limit recreational facilities
- Constructing recreational facilities will remove woodland adjacent to residential homes

### OPTIONS

- Fitting three fields is highly unlikely given site constraints
- New parking and drive to access recreation area needed
- Retaining walls needed throughout


## MILLVILLE RECREATIONAL PARCELS - EASTERN PARCEL FITTING STUDY

### EXISTING CONSTRAINTS

- Wooded area, even with tree planting recreational facilities would remove woodland from adjacent residential homes
- With 10-15' of grade change, the site will need to be regraded to fit soccer fields
- Recreation facilities will encroach upon conservation easements

### OPTIONS

- 2 Soccer fields **could** fit with the best orientation
- 1 Baseball field does not fit
- 1 Softball field can fit within the parcel, but overlaps the wildlife zone and **removes space for** parking
- A parking lot is possible with access from either street
- Tree buffer will need to be established between fields and neighbors



# PARKS & RECREATION OPPORTUNITY PARCELS

## MILLVILLE RECREATIONAL PARCELS - BEACH ACCESS

### EXISTING CONSTRAINTS

- Street will need to be realigned
- No accessible pathway to beach
- Wide intersection used for parking but not safe
- Minimal visibility down to beach from street

### OPTIONS

- Improving beach access and facilities is the most feasible and has the least impact on the environment and neighborhood
- Boardwalk and dock
- 5% Accessible Pathway
- Steps from street to beach
- Increase visibility of the beach by removing or limbing up trees by crosswalk
- Revegetate slope with grasses & native plants
- Crosswalk and sidewalk from parking lot - 10 spaces
- Planting strip between street and sidewalk
- Right angle intersection with possible location of drive to access recreational fields



# PARKS & RECREATION OPPORTUNITY PARCELS

## 73 LAWRENCE ROAD

### EXISTING

- Open Lawn
- Marsh & Wetlands
- Informal pull-off parking area

### CONSTRAINTS

- The primary issue is that the site is next to a busy intersection. The intersection is also has wide radius corners leading to fast traffic. Traffic calming measures are needed to slow traffic next to where new park facilities would be located.
- Invasive plants in lawn area should be removed as well as vegetation at the wetland edge should be thinned

### OPTIONS

- New parking area needed
- Remove invasive plants
- Create meadow
- Nature themed playground
- Open up view into wetlands



# PARKS & RECREATION OPPORTUNITY PARCELS

## 73 LAWRENCE ROAD - DESIGN CONCEPT

### OPTIONS

- Intersection design must be addressed to make street crossing safe
- Crosswalk with surfacing that contrasts with roadway to make crossing clearly visible
- Fence to provide visual break safety barrier between lawn and roadway
- If used by residents from adjacent retirement home, a pulloff parking area could be optional.
- Bocce ball courts, lawn games, small gazebo all feasible in lawn area
- Open lawn large enough for circular walking path
- Boardwalk extends into wetlands to view wider area

## LITTLE SAUGUS FIELD

### EXISTING

- Wooded knoll on northern end
- Wide open lawn
- Great accessibility
- In heart of res. neighborhood, opportunities for families

### OPTIONS

- 50' Baseline tee ball field also can fit
- Playground and open lawn or meadow
- Walking path around site is 1/5th mile long
- Pergola or picnic pavilion




