1. Chair Comments

A \$2,500 donation was received by the governor's inauguration fund. The Sal's / Tuscan donation will be presented at the Sal's upcoming ribbon cutting.

2. Review of Minutes

3. Bench Donation

Spicket Lodge 85 would like to donate a bench for the 275th anniversary. They are working with Larry Belair and Cindi Woodbury to put together a ribbon cutting. The consensus was that near the end of August would be best for the Commission.

4. Salembhram

Mr. Shamshoyan passed around a map and schedule for Salembration. The Commission discussed. Mr. Shamshoyan discussed need for volunteers at the bounce houses. Larry Seaman will be providing photography for the Commission. The Commission discussed the status of volunteers. Mr. Shamshoyan discussed some changes to the schedule. Ms. Mailloux presented two options for the “Key to the Town” and the Commission decided to present a key, a ribbon with Salem colors, and a certificate for the recipient of the key. There was an update on the banner for the stage, it is being finalized now.

Ms. Mailloux discussed potential concerns with Primex coverage and bounce houses and is looking at what other communities have done for insurance coverage for similar events related to

1 bounce houses. She is working on coming up with a solution and just wanted the Commission to
2 know. Ms. Mailloux can provide an update to the Commission once it is available.

4 Mr. Tylus will be selling merchandise live at Salembration. Ms. Isabelle said that she can
5 provide receipt slips to Mr. Tylus. Mr. Shamshoyan noted that there will be a volunteer tent next
6 to the merchandise tent. The Commission will have lanyards for volunteers; Ms. Russell
7 suggested requiring volunteers to sign in at the volunteer table. Mary Anne's Diner asked if they
8 could have a table or provide a gift card. Ms. Russell will reach out. The Commission was good
9 with the DPW being allowed to buy and install a banner to represent themselves at cost.

11 Ms. Mothon provided an update on the historical society items for Salembration. She can recruit
12 some additional volunteers for historical society parts of the Salembration event. She provided an
13 update on the historical films that have been shown at the Old Town Hall. Ms. Mothon provided
14 an update on historical society outreach to local papers.

16 Ms. Russell provided an update on the scavenger hunt submissions. Various groups are donating
17 to get rewards for all of the eight submitters. The submissions will be on display at the three
18 seasons café at the High School.

20 The Commission discussed further logistics for set up on Friday, August 8 and Saturday, August
21 9. Commission members were asked to show up at 10 am and coordinate where to park.
