GENERAL SPECIFICATIONS:

REPLACEMENT COOLING ONLY SPLIT SYSTEM

Furnish and install one (1) 48,000 BTUH cooling only unit Carrier Model # 38CC048410 S # F668499 condensing unit and Carrier Model # 40FS200300 S # K758920 air handler or equivalent.

Scope of project

- Recover refrigerant from existing system and dispose of
- Disconnect condensing unit refrigerant piping and wiring
- Remove and dispose of condensing unit
- Disconnect condensate piping and electrical wiring from air handler
- Remove and dispose of air handler
- Remove existing refrigerant piping
- Install new indoor Carrier 4.0 ton Fan coil or equivalent in place of removed fan coil
- Install new outdoor Carrier Condensing unit Model 24ABB348A005 4.0 ton 208/230/3/60 or equivalent
- Install new refrigerant line set from outdoor condensing unit to the indoor fan coil
- Reconnect condensate drain piping
- Reconnect electrical wiring (Does not include replacing disconnect switch if need). No new electrical power wiring
- Start and test the system operation
