Updates:

Pickleball Courts: The new pickleball courts at Michelle Memorial Park are now complete and ready for public use. Due to the seasonal departure of many seniors and pickleball enthusiasts to warmer climates, we have decided to postpone the official grand opening until the spring. Basketball Courts at Hedgehog Park: We are making progress on the new basketball courts at Hedgehog Park. Currently, we are in the final stages of scheduling a date for the contractor to come in and complete the project. Cyanobacteria Warning for Arlington Mill Pond

Arlington Mill Pond remains under a Cyanobacteria Warning due to elevated bacteria levels exceeding the state limit of 70,000 cells/mL. Recent test results are as follows:

- Shore Drive Beach: 0 cells/mL
- Mary Ann Ave Beach: 174,000 cells/mL
- Cove Rd Ext: 42,000 cells/mL
- Glen Road: 237,000 cells/mL

This warning will remain in place until further notice, as we work with the appropriate agencies to monitor and address these levels.
