**Resolution #2025-35**  
**Adoption of Economic Revitalization Zones**  
**Renaming and Expansion**

**WHEREAS:** The State of NH has an economic development tool entitled Economic Revitalization Zones (ERZs) in various commercial and industrial areas of municipalities whereby businesses can apply and receive credit for their state business taxes, if they expand and create jobs or make capital improvements eligible for the program; and,

**WHEREAS:** The Town of Salem has four (4) ERZs, of which three (3) are currently desired to be renamed and expanded after consultation with the State of NH and Salem Economic Development Committee (EDC), and,

**WHEREAS:** The Salem EDC unanimously recommended to the Town Council the proposed renaming and expansions of the three listed below ERZs at their October 21, 2025 meeting.

**NOW, THEREFORE, BE IT RESOLVED BY THE SALEM TOWN COUNCIL THAT:**

The Salem Town Council hereby adopts and requests to the State of NH the following changes to Salem's ERZs:

- Renaming of three ERZs for simplicity, updated accuracy, and clarity:
  - **Mixed Use Commercial ERZ** (formerly Depot Intersection Northwest, Tuscan Village)
  - **I-93 Corridor ERZ** (formerly West Side I-93 Exit 2)
  - **Northeastern Blvd ERZ** (formerly Former Cisco / Celestica Plant, 9 Northeastern Boulevard)
- Expansion of Mixed Use Commercial ERZ to include parcels that comprise the Mall at Rockingham Park
- Expansion of I-93 Corridor ERZ to include parcels between NH Route 97 to the north, South Policy St. to the east, I-93 to the west, and NH Route 38 to the south with parcels that are primarily zoned Commercial / Industrial B
- Expansion of Northeastern Blvd ERZ to include 11 Northeastern Blvd and 39 Brookdale Road




